Open Air Burning

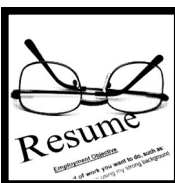


Council recently updated the Open Air Burning by-law to include two new general conditions in which the permittee must comply with when burning. These two new conditions are as follows:

10. *Common courtesy for your neighbours is expected (clothes lines, open windows, etc). If we receive a complaint, Echo Bay Fire Services must respond and the permit may be cancelled and/or the fire extinguished.*
11. *Burn only dry materials. All other material such as petroleum products, plastics, rubber, painted lumber, etc., that will cause excessive smoke or fumes shall not be burned. Mixed demolition debris is not suitable for open air burning.*

If you plan to burn please make sure to get a FIRE PERMIT, free of charge, from the Municipal Office. If you are caught burning without a permit, fines will apply.

Council has set disposal site hours for spring clean-up days as:

Friday	May 27, 2016	10 a.m. to 8 p.m.
Saturday	May 28, 2016	9 a.m. to 5 p.m.
Sunday	May 29, 2016	9 a.m. to 5 p.m.

There is no charge for all household waste during these days, businesses are excluded. Items to be burned will not be accepted if a fire ban is in place. Do not put recyclable material in the land fill!
